2008 FLEMISH FARM TERMS AND CONDITIONS

1. All applications must be submitted on the appropriate form, which must be signed by the member – such signature being the acceptance of these conditions. All applications must be accompanied by **payment of a 10% booking deposit.**
2. If your application is successful you will be liable for the total amount due which will be invoiced in two equal parts on 1st April 2008 and 1st July 2008. **Invoices must be paid immediately.**
3. If your application is unsuccessful then the deposit will be returned to you.
4. The 2008 season is defined as the period between 1st March 2008 and 30th September 2008. **All stables and chalets must be vacated by 30th September 2008.**
5. Chalet charges cover all maintenance costs, and include a contribution to insurance and water rates.
6. The chalet charge **does not** cover the cost of electricity. Electricity is paid for by the occupant via a coin meter.
7. Individuals or groups of individuals are responsible for the payment of:
 - a. Council Tax (at the rate charged by the Council for the year, this will be added to the invoice)
 - b. Their grooms
 - c. Vets' fees and farriers' charges
 - d. Their ponies' feed and bedding
 - e. Their own transport costs
 - f. Their chalet electricity
 - g. Their own insurance (including ponies, tack and equipment and Employer's Liability)
 - h. Their own TV Licence
 - i. Any personal or group telephone costs
8. All grooms must reside on the Flemish Farm property.
9. Hard hats must be worn **at all times** when riding at Flemish Farm or in Windsor Great Park.
10. No dogs are allowed. No other pets are allowed without the prior permission of Guards Polo Club.
11. All persons must abide by the rules of Flemish Farm and the Royal Farms.
12. Any changes of groom must be notified to Guards Polo Club immediately.
13. Guards Polo Club will allocate grooms to chalet numbers at the start of the season. Any changes to occupancy must have the prior agreement of Guards Polo Club.
