**The Proposing of Applicants**

Each Applicant for admission shall be proposed by a current Member of the Club, who must have a personal knowledge of the Applicant. The Applicant's name, usual place of residence, date of birth, profession, occupation or other description, the place where he/she exercises his/her profession or carries on business and the name of the firm to which he/she belongs shall be stated on the proposal form.

**Responsibilities of the Proposer**

The proposer must supply a detailed statement of support and recommendation for the Applicant. They shall be answerable for the eligibility of their Applicant in all respects and shall supply to the Board of Directors such information concerning the Applicant as the Board of Directors shall reasonably require.

**Method of Election:**

The election of Members shall be by the Board of Directors, who shall have a discretion to appoint a sub-committee for the purpose.

**Notification of Election:**

Immediately after the election of any Applicant notice thereof shall be sent direct to his/her address. A request for payment of his joining fee and subscription shall also be sent.

**Taking up Election:**

A newly elected Member shall not participate in any of the benefits and privileges of membership of the Club until he/she has paid the joining fee and subscription. The election of any new Member who does not pay the joining fee and subscription within one calendar month of the date of election shall be absolutely void, unless the delay is accounted for to the satisfaction of the Board of Directors or the appropriate sub-committee.

**Rejected Candidates**

Any candidate who is rejected for membership by the Board of Directors shall not be admissible to the Club thereafter either as guest or under any reciprocal arrangement.
